## **2026 Online July Sale** **Vendor Information**

The Tattersalls Online July Sale is due to open for bidding at 11:00am on Tuesday 30<sup>th</sup> June.  
Bidding is scheduled to close from 11:00am Wednesday 1<sup>st</sup> July.

### **Pre-Sale**

- **Contact Information and Lot Location (Required)**
  - Vendors are required to provide an accurate location and contact information for all Lots to be offered in the online sale. This information must be provided **at time of entry**. This is in order for prospective Purchasers to make arrangements to inspect a Lot prior to bidding and to organise collection if they are the successful bidder.
  - This information can be set in your [Tattersalls Online Account](#) by selecting **My Lots > Entry Forms Processed > Set Details**.
- **Health Documentation (Required)**
  - You will have received notification of the required Health Documentation for online sales.
  - Documentation must be uploaded to your [Tattersalls Account](#) by **5:00pm on Friday 26<sup>th</sup> June**.

- **Veterinary Certificates (Required)**
  - This Condition applies where the Lot is described as a Yearling (other than one sold prior to 1st July to which this sub-condition does not apply), a Two-Year-Old prior to 1st April, a Store, a Horse in Training or a Point to Pointer.
  - A Five-Stage Veterinary Certificate **must be completed on the Tattersalls approved Veterinary Certificate template** which can be found on [here](#). This certificate should be dated no earlier than **14 days** prior to the commencement of the auction and uploaded to the Tattersalls website by the Vendor no later than **5:00pm on Friday 26<sup>th</sup> June**.
  - The Vendor must facilitate the re-examination by the Purchaser's veterinary surgeon by 5:00pm on the second day following the day on which the Lot was sold, should the Purchaser request this.
- **Photos and/or Videos (Required)**
  - It is mandatory for horses offered in the Online Sale have photos and/or videos provided. These must be uploaded **before the catalogue is published**.
  - A guide on how to provide these is enclosed later in this document.
  - Tattersalls can assist in arranging a professional videographer as part of the enhanced entry packages. Please contact Katherine Sheridan or Ross Birkett for more information via email to [tattersallsonline@tattersalls.com](mailto:tattersallsonline@tattersalls.com).
- **Vices & Declarations**
  - Any vices or additional declarations you wish to make can be made at time of entry. Vices/declarations must be provided in writing to Tattersalls no later than **12:00p.m. on Wednesday 24<sup>th</sup> June**.
- **Additional Information (Recommended)**
  - The height & weight of any Lot(s) can be added to the Tattersalls website provided they have been supplied to Tattersalls on a dated certificate completed by your veterinary surgeon.
  - Repository – The Tattersalls Repository is available for this sale for Vendors to provide any X-Rays and Videoscopes. Registered Veterinary Surgeons can access this information remotely and you will be notified of any viewings via our notification system.
- **Setting Reserves**
  - The minimum selling price for this Sale is 1,000 guineas.
  - Vendors must set reserves **no later than 9:00am on Tuesday 30<sup>th</sup> June**.
  - Lots may be offered unreserved or will otherwise be subject to a reserve which shall be either the minimum selling price or any higher reserve price in respect of which Tattersalls have received written notification from the Vendor or has been added via your Tattersalls account.
  - How to set Reserves

- Login to your [Tattersalls Online Account](#).
- Click '**My Lots**' followed by '**Entry Forms Processed**'.
- Click '**SET/EDIT DETAILS**'
- Enter '**Starting Bid**' (Optional)  
(This bid will be placed on your behalf at the start of the Sale. If there are no other bids, it will be published as a Vendor buy-in.)
- If no starting bid is placed your Lot will begin at 900 guineas.
- Enter **Reserve** Amount
- Click **Submit Request** (Important)

### **During the Sale**

- Follow the Sale Online
  - You can follow the sale online at <http://www.tattersallsonline.com/>
  - You will also receive notifications when any bids are placed on your Lot(s).

### **Post-Sale**

- As with a conventional Sale, any Lot is at the Purchaser's risk from Fall of Hammer, therefore Purchasers are strongly advised to have Fall of Hammer Insurance in place.
- Collection of Lots
  - Successful Purchasers will be required to collect a purchase by 5:00pm on the fourth day after the day on which the Lot was sold.
  - Purchasers will require authorisation and be emailed a pass-out from Tattersalls. You will also be emailed a copy which should be checked against the Purchaser's copy before releasing a Lot.
  - Purchasers wishing to check the pregnancy of any in-foal mares must do so with a vet of their choosing prior to the horse leaving the Vendor's premises.
- Lots in the **Online July Sale** will be subject to post-sale blood testing (excluding foals).
- Any Lot offered for sale with a Veterinary Certificate is subject to a post-sale re-examination.
- The Vendor is responsible for costs incurred relating to the keep of a Lot between the time bidding closes on a Lot and either 5.00pm on the fourth day after the day on which the Lot is sold or the time the Lot is collected by the Purchaser, whichever is soonest.

### **Photos & Video Guidance**

In advance of the upcoming **Tattersalls Online July Sale**, it is **MANDATORY** to take photos and videos of your Lots and upload these to the Tattersalls Website for prospective Purchasers to view. We strongly recommend these are uploaded BEFORE the catalogue is published.

Alternatively, to find out more about the Tattersalls Online enhanced entry packages, where we can arrange for a professional to take photos and videos of your draft at an additional cost, please contact Katherine Sheridan or Ross Birkett to discuss your options.

It is recommended to use a professional videographer to do these for you however, you can do these yourself via most modern smartphones. Please find some useful resources below –

The following photos and/or videos are recommended.

- Side on confirmation image showing all four limbs.
- Photos and/or video from the front and rear of the horse.
- Footage of the horse walking side on - left to right and right to left.
- Footage of the horse walking directly towards and away from the camera.
- Additional photos of all four limbs may also be useful for Vendors of horses in training.

## Uploading to Tattersalls

Once you have the photos and videos you can upload these via your Tattersalls Online Account (<https://secure.tattersalls.com/4DCGI/MyAccount>)

If you are already registered, login and go to '**My Lots**' and then '**Catalogued Lots**' where you will see details of any Lots you have catalogued in the upcoming sale.

If you have employed a professional videographer, they may be able to upload photos and videos directly to Tattersalls on your behalf.

If you are doing this yourself:

- Log in to your Tattersalls Account, go to '**My Lots**' and select '**Entry Forms Processed**' from the lefthand menu
- Click on the film "+" icon that appears next to your entry details.
- Here you can upload multiple photos and videos for your Lot(s) which are approved by Tattersalls before they are added to the Tattersalls Online website.
