# 2) ENTRIES

- a) Please make entries via the Tattersalls Online website or by logging in to your Tattersalls Account.
- b) Tattersalls check entry details against Vendor information only. They are believed to be correct, but the responsibility is entirely the Vendor's. Tattersalls are in no way responsible for any misdescription.
- c) The full Terms and Conditions are available to download under the Info tab of the Tattersalls Online website.

## 3) COMMISSION & FEES (Condition of Sale 3)

- a) The standard entry fee for this Sale will be £160 + VAT for each Lot catalogued. A tiered entry package is available for an additional cost which includes professional photos and videos at a cost of £150 + VAT (\*subject to availability) and race replays at a cost of £100 + VAT per race. Details of the Tiered Entry Packages can be discussed with a member of the Tattersalls Online team by emailing tattersallsonline@tattersalls.com or by calling +44 (0) 1638 665931.
- b) Lots withdrawn from this Sale without a veterinary certificate to Tattersalls' satisfaction after 12:00pm Wednesday 24<sup>th</sup> June ("the FOC Withdrawal Date") will incur a withdrawal fee of £200.
- c) The Sale will be conducted in Guineas.
- d) Commission is payable to Tattersalls by the Vendor at the rate of **5**% of the price of each Lot sold (See Condition of Sale 3.2).
- e) If the Vendor instructs Tattersalls to publish the Lot as bought-in, then the rate of commission is reduced to 2.5% for any Lot described as a Yearling and to zero for any other Lot (See Condition of Sale 3.2).
- For each Lot sold at Tattersalls Sales, the Vendor will pay £3, which Tattersalls will deduct from the sales proceeds to support the Retraining of Racehorses Charity (See Tattersalls Condition of Sale 22.3).

# 4) RESERVE PRICE (Condition of Sale 3.3)

- a) All Lots offered for sale will be subject to a reserve price which shall be either the minimum selling price or that specified by the Vendor ahead of the start of the Online Auction.
- b) Vendors must set reserves no later than 9:00am on the day on which bidding is scheduled to commence via their Tattersalls Online Account by selecting 'Catalogued Lots' and clicking on SET/EDIT DETAILS
- The minimum selling price at this Sale is 1,000gns.

# 5) PEDIGREE PROOFS

- a) You will receive email notification when your pedigree proofs are available to view on your <u>Tattersalls Online Account.</u> Vendors are reminded that they alone are responsible for the accuracy of their catalogue details, and they are advised to check these proofs with care.
- b) Any requested amendments to these pedigree proofs should be sent to us immediately via your Online Account at the Tattersalls Online website (www.tattersallsonline.com) by 12:00pm Wednesday 24<sup>th</sup> June at the latest. After this date any important amendments or updates will be included on the updates page of the Tattersalls Online website.
- c) Proofs are available to you the Consignor and therefore, where there are other owners you should send a copy of the proof to them for this purpose.

#### 6) CATALOGUING

a) Lots will be catalogued at the discretion of Tattersalls.

## 7) ONLINE CATALOGUE

- No catalogues will be printed for Tattersalls Online Auctions. All Lots will be listed on the Tattersalls Online website.
- b) The catalogue will be available to view on the Equineline Sale Catalogue App.

## **8) VENDOR OWNERSHIP** (Condition of Sale 8.11)

a) Please refer to this Condition to see what is required where there has been any change in the ownership of a Lot between the date of the online sales entry form and the time at which the Lot is put up for auction.

# 9) HEALTH DOCUMENTATION

- a) Lot documentation requirements are available on the Sale Documentation Notice and should be uploaded via your <u>Tattersalls Online Account</u> ahead of the start of Sale. Template certificates for completion by your vet are available to download <u>here</u>.
- b) Vendors of any Lot displaying signs of suspected ringworm, including visible skin lesions, must provide a negative skin scraping certificate in advance of the sale. Please refer to Sales Documentation Notice.

## 10) PRESENTATION OF LOTS

- a) Vendors should submit both their contact information and the viewing location of each Lot at the time of entry using their Tattersalls Online Account by clicking 'Entry Forms Processed' and clicking on SET DETAILS
- b) Only those registered to bid can view the contact details and viewing location of each horse using the Lot page.
- c) To ensure that Lots realise their full potential, any entries listed should be made available to view to prospective Purchasers at a mutually convenient time.
- d) Prospective Purchasers are advised to inspect each Lot prior to bidding by contacting the Vendor, whose approval must also be obtained before a veterinary inspection is arranged.

### 11) REGISTRATION COSTS

a) Where costs are incurred by a Purchaser in registering a Lot as catalogued or in obtaining all required registration papers for a Lot, these costs will be the responsibility of the Vendor. Vendors of Lots coming from overseas must apply to their Stud Book Authority for export certificates to be sent to Weatherbys.

## 12) INSURANCE

- a) We strongly recommend that insurance cover is arranged against mortality and theft.
- b) The Lot and its progeny (if any) shall be at the Purchaser's risk in all respects until the time the Lot is sold.

## 13) SALES WITH A VETERINARY CERTIFICATES (SUBJECT TO RE-EXAMINATION) (Condition of Sale 15.2)

- a) This Condition applies where the Lot is described as a Yearling (other than one sold prior to 1st July to which this sub-condition does not apply), a Two-Year-Old prior to 1st April, a Store, a Horse in Training or a Point to Pointer.
- b) This Veterinary Certificate should be completed on the approved Tattersalls Veterinary Certificate template which can be found on the Tattersalls website.

- c) The Certificate must be dated no earlier than 14 days prior to the commencement of the auction and uploaded to the Tattersalls website by the Vendor no later than 3 days prior to the time bidding commences.
- d) The Vendor must facilitate the re-examination by the Purchaser's veterinary surgeon by 5:00pm on the second day following the day on which the Lot was sold, should the Purchaser request this.

# 14) DRUGS (Condition of Sale 24)

- a) This Condition applies where the Lot is described as a Yearling (other than one sold prior to 1st July to which this sub-condition does not apply), a Two-Year-Old prior to 1st April, a Store, a Horse in Training, a Horses Out of Training or a Point to Pointer but not otherwise.
- b) Vendors should note the above horses sold on Tattersalls Online will be subject to the testing for Nonsteroidal Anti-inflammatories; Corticosteroids; Clenbuterol, Anabolic Steroids and Bisphosphonates.

## 15) PIROPLASMOSIS (Condition of Sale 25)

a) This Condition applies where the Lot is described as a Mare, a Stallion, a Yearling (other than one sold prior to 1st July to which this sub-condition does not apply), a Two-Year-Old prior to 1st April, a Store, a Horse in Training, a Horses Out of Training or a Point to Pointer but not otherwise.

#### 16) REPOSITORY

a) Tattersalls offers an Online Repository in which Vendors may place pre-sale x-rays, video endoscopies and other stipulated information. Use of the Repository is subject to Tattersalls' Repository Rules which are available on www.tattersalls.com/information and is only accessible to veterinarians registered with Tattersalls.

# 17) COLLECTION

- a) Following the sale of the Lot, the Vendor and Purchaser will be notified by text/email.
- b) Tattersalls will notify Vendors to release each Lot once payment has been secured.
- c) The Purchaser shall take away at his own expense every Lot purchased by him from the Vendor's Premises before 5.00 p.m. on the fourth day after the day on which the Lot is sold, provided that Tattersalls has given its prior written consent thereto.
- d) In the event that the Lot has not been collected by the stipulated time, the Purchaser shall pay on demand to the Vendor the reasonable expenses not exceeding £35 per day incurred by the Vendor of and in connection with the Lot for any day or part of a day the Lot remains on the Vendor's premises beyond the stipulated time.

#### 18) MAKE AN OFFER

a) Registered bidders can "make an offer" for Lots that are not sold or bought-in, after the bidding has closed. Offers can be made through the Tattersalls Online website and are forwarded to the vendor of the Lot for their approval.
