# TATTERSALLS SALES DOCUMENTATION NOTICE

Failure to lodge the correct documentation may result in horses being refused entry to Park Paddocks or to outside standings designated by Tattersalls. Individual Lot requirements may be found in your Tattersalls Online Account. If you have any doubts regarding Sales documentation, please consult your Veterinary Surgeon or contact Liz Wood in the Bloodstock Department at Tattersalls. Please note new protocol regarding Ringworm (item 3, page 2).

Health certificate templates, information on testing intervals, and classification of Low and High Risk Lots can be downloaded from the Tattersalls main website, <a href="https://www.tattersalls.com">www.tattersalls.com</a>

Test results and completed forms should be uploaded to your Tattersalls Online Account pre-arrival of your Lots. Should you receive any non-negative results, please call Liz Wood in the Bloodstock Department to discuss. All health documentation is approved pre-Sale by the Bloodstock Department so there is no need to provide duplicate copies on arrival at the Control Office.

## 1. Pre-Sale Health requirements for entry to Park Paddocks

CONTAGIOUS EQUINE METRITIS (CEM) CERTIFICATES (STALLIONS, MARES & FILLIES IN/OUT OF TRAINING. Not required for Low Risk 2-year-old fillies)

For swab requirements, please refer to the CEM Regulations Notice at our main website, www.tattersalls.com

### **COVERING CERTIFICATES (MARES BELIEVED IN FOAL) (Condition of Sale 10.4)**

Prior to the time of Sale of the mare, either a paper covering certificate must be lodged with Tattersalls or we must have received written notification from the appropriate Stud Book Authority that the covering has been recorded electronically. Broodmares must be registered with Weatherbys or the appropriate Stud Book Authority.

#### EHV-1,4 (RHINOPNEUMONITIS) VACCINATIONS (IN-FOAL MARES)

It is a compulsory requirement for in-foal mares to be vaccinated against EHV-1,4 details of which must be recorded in the passport. Vaccines may only be administered and recorded in the passport by a registered Veterinary Surgeon. Latest vaccine must be dated within 2 months of the Sale. Where no vaccinations are shown in the passport, the mare will be isolated in Park Paddocks or at an outside standing and will be sold in absentia.

#### **EQUINE INFECTIOUS ANAEMIA (EIA) REQUIREMENTS (PRE-SALE ENTRY)**

If a Lot has been outside Great Britain or Ireland since January 1<sup>st</sup>, 2026, a blood sample **must** be taken within 15 days of the first day of the Sale (ELISA or Coggins are both acceptable). **NB** <u>High Risk Lots will require two blood tests for EIA (taken at least 7 days apart with the 2<sup>nd</sup> result reported within 15 days of the Sale).</u>

## EQUINE VIRAL ARTERITIS (EVA) CERTIFICATES (STALLIONS, MARES, FILLIES & COLTS IN/OUT OF TRAINING)

### NOT required for Geldings/Foals/Yearlings, Two-Year-Olds in February Sale, Craven Breeze Up and Guineas Breeze Up Sales.

Your Veterinary Surgeon should take a blood sample within 30 days of the first day of the Sale (Enzyme-Linked Immunosorbent Assay (ELISA) or Serum Neutralisation Test (SNT) are both acceptable). Lots should wherever possible be isolated after sampling. Samples must be sent to one of the following as appropriate: APHA Weybridge, Newmarket Equine Hospital (NEH), Rossdales Laboratory (Newmarket), Axiom Veterinary Laboratories (Devon), BioBest Laboratories (Pentlands Science Park, Penicuik, Midlothian), BioTe Veterinary Laboratories, Donnington Veterinary Group (Newbury), Equine Diagnostics Laboratory (Fethard Equine Hospital) Fethard, The Irish Equine Centre (IEC) or Irish Department of Agriculture, Liphook Equine Hospital, Rainbow Equine Hospital (Malton) or to an accredited Laboratory in the country of export approved by the local Stud Book Authority.

Where the initial test proves positive, the Lot should be isolated and re-sampled 14 days or more after the initial sampling to see whether the titre is equal to or less than the initial reading.

Please note that horses classified as "High Risk" require <u>two</u> blood tests for EVA with the second sample taken at least 7 days after the first and must be taken within 30 days of Sale.

#### FILLIES' EXAMINATION CERTIFICATES (FILLIES IN/OUT OF TRAINING)

Vendors may arrange for their Veterinary Surgeon to complete this form. Please note that certificates are not accepted for 2-year-old fillies.

Certificates should be dated within 30 days of the first day of Sale. No announcement regarding these certificates will be made from the Rostrum.

### **INFLUENZA VACCINATIONS**

Yearlings (Two-Year-Olds in February Sale): As a minimum, Lots must have been given the first 2 vaccinations of the primary course.

**Broodmares:** Full vaccination history and must include an up-to-date booster.

<u>Horses In Training</u>: Lots must have had a complete course of vaccinations in accordance with current BHA requirements. Please ensure that all details of vaccinations are recorded in the passport. If in doubt, please consult your Veterinary Surgeon.

# PASSPORTS (ALL LOTS)

Passports must be lodged at the Sales Section in the Main Sales Office on arrival at Park Paddocks. All Lots must be microchipped, and passports updated with Weatherbys. For Lots issued electronic passports (e-cards) by Weatherbys, these should be lodged with the passport.

Please check that the markings in the passport match those of your Lot. Discrepancies must be notified immediately to the Stud Book Authority that hold the registration details of the Lot. Please also ensure that the Medicinal Treatment section of the passport (either A or B) is completed prior to Sale. Where a passport does not contain this section, please contact Weatherbys or the relevant Stud Book Authority to update the passport in advance of the Sale.

#### PRE-SALE PIROPLASMOSIS TESTING (Condition of Sale 26)

If submitting a pre-Sale test, a blood sample should be taken within 15 days of the Sale and be sent to an approved laboratory for testing by c-ELISA & Indirect Immunofluorescent Antibody Test (iFAT). If the result is positive or doubtful, an announcement will need to be made at time of Sale in order to preclude testing and return.

#### PREGNANCY CERTIFICATES (MARES BELIEVED IN FOAL) (Condition of Sale 10.5)

The relevant section of the CEM certificate must be completed by your Veterinary Surgeon and dated within 30 days of the first day of the Sale.

### STRANGLES CLEARANCE DECLARATION

A Strangles Health Declaration should be submitted via your Tattersalls Online Account at least 7 days before the start of the Sale.

# 2. Mandatory testing for post-sale movement of Lots for movement to an EU country and Northern Ireland

## **EIA (ALL LOTS)**

- EIA testing must be carried out using the Coggins method and a blood sample should be taken within 70 days of the Sale for ALL Lots.
- This test should be carried out at the APHA Weybridge Laboratory in the UK, The Irish Equine Centre (IEC), or to an approved laboratory in the EU (a list of approved French laboratories is available on request). This will expedite the export of those Lots returning to the EU or Northern Ireland after the Sale.

# OFFICIAL VETERINARIAN DECLARATION (OVD) (GB-BASED LOTS ONLY)

 The official DEFRA template for the OVD and guidance for completion may be found at our main website, www.tattersalls.com, and must be completed by an approved Official Veterinarian (OV).

## 30-DAY HEALTH DECLARATION (EU-BASED LOTS/ALL OTHER COUNTRIES)

• The approved wording template for the 30-day health certificate as per our main website, <u>www.tattersalls.com</u>, must be used and should be completed by your veterinary surgeon.

### **RESIDENCY DECLARATION (ALL LOTS)**

• Required for <u>ALL</u> Lots. The approved wording template may be found at our main website, <u>www.tattersalls.com</u>. The Vendor should complete for each Lot.

# 3. Guidance regarding Ringworm

- Vendors of any Lot displaying signs of suspected ringworm, including visible skin lesions, must provide a negative skin scraping certificate in advance of arrival at Tattersalls' premises. Please send to <a href="mailto:liz.wood@tattersalls.com">liz.wood@tattersalls.com</a>
- Lots displaying signs of ringworm which have not had the appropriate documentation provided may be denied access to Tattersalls' Premises, isolated and/or withdrawn from the Sale.
