Health Documentation

- Full Flu Vaccination Records must be uploaded for all entries in the Online Breeze Up Session. These must be uploaded to your Tattersalls Account by **Monday 13th May**.

Photos/Videos

- It is mandatory for all entries to have photos and videos uploaded to the Tattersalls website by **Thursday 30th May**. A guide is enclosed later in this document.
- Tattersalls can arrange professional photos and videos to be completed at Chelmsford City on the day of breezing or alternatively arranged prior to the 30th May at a cost of $\pounds 150 + VAT$.
- Once the catalogue is published on the Tattersalls Online website, viewing statistics for your Lot(s) can be viewed in your Tattersalls Online Account under the heading 'Web Stats'.

Veterinary Information

- All Lots breezing on Tuesday 21st May will be subject to a pre-sale blood sample being taken at Chelmsford City. This may be tested post-sale at the request of the purchaser for proscribed drugs.
- It is mandatory to complete a Five-Stage vetting on the Tattersalls approved veterinary certificate template after the breeze up, prior to the sale. This must be uploaded to the Tattersalls website by **5:00pm Friday 31st May**. A copy of this template is enclosed with this information.
- The height & weight of any Lot may be measured at Chelmsford City on Tuesday 21st May or may be provided to the Tattersalls Online website prior to the sale provided it has been certified by a veterinarian.
- Consignors may upload pre-sale X-Rays and a Video Endoscopy. This information should be lodged in the Tattersalls Repository to be made available for inspection.

Arrivals

- Horses may arrive at Chelmsford City Racecourse from 8:00am on Tuesday 21st May.
- Stables shall be allocated on arrival at Chelmsford City.
- Number cloths must be collected on arrival and on production of your horse's passport. A charge of £75.00 shall be incurred for any number cloth not returned.
- A Veterinarian and Farrier will be available on course if required.

Breeze

- Lots will breeze on the all-weather racetrack surface.
- The racetrack will be available for pre-breeze exercise canter from 9.00am 10:00am.
- The Actual Breeze will commence from 10:00am
- There will be up to 3 furlongs of gallop allocated to breezing. Consignors may breeze the distance of their choice and disclose the intended breeze distance prior to breezing.
- An Order of Breezing will be completed on the day

Sale

All Lots entered in the Online Breeze Session will be offered in the June Online Sale which takes place on the Tattersalls Online website on Wednesday 5th of June – Thursday 6th of June 2024.

RIDERS INSURANCE

Vendors are advised to consider most carefully, and preferably with their insurance advisers, the question of insurance of riders who work for them during the breeze up session. Some jockeys may be covered under a personal accident scheme arranged by the Professional Jockeys Association. Other riders may be covered separately but Vendors are advised to review the question of accident insurance in respect of all staff employed by them. Additionally, Vendors are advised to have in place liability insurance in respect of their business.

Tattersalls Photos & Video Guidance

In advance of the upcoming Tattersalls Online June Sale it is a mandatory requirement to take photos and/or videos of your lots and upload these to the Tattersalls Website for prospective purchasers to view.

It is recommended to use a professional videographer to do these for you however, you can do these yourself via most modern smartphones. Please find some useful resources below -

The following photos and/or videos are recommended:

- Side on conformation image showing all four limbs.
- Photos and/or video from the front and rear of the horse.
- Side on footage of the horse walking near side and off side
- Footage of the horse walking directly towards and away from the camera.
